Trustee Scholarship Matching Program (SCGTS)

The Behrend College Trustee Matching Scholarship Fund is the primary target for fund-raising this year. Trustee Matching Scholarships are literally twice as valuable as traditional scholarships, which award 5% of the principal each year. Our Trustee Scholarships pay that 5% plus 5% additional funds *from* the University, effectively doubling the scholarships available to Behrend students.

- Scholarship fund will provide aid to students with significant financial need.
- Behrend trustee scholarship recipients have an average GPA of 3.41.
- Individual awards will range from \$1,250 to \$2,500 per year.

The Behrend College Scholarship Awards Committee will determine the recipients from a pool of eligible students provided by the Office of Student Aid at University Park.

The President’s Club

Join Penn State donors who make an unrestricted gift of \$2,500 or more per academic year to one of the College or Campus Future Funds. This can be accomplished with a payroll deduction of \$209 per month.

Mount Nittany Society

Individuals who have cumulative giving to the University of at least \$100,000 (\$250,000 as of 12/31/07) are members. Gifts can be made through any combination of the following means: outright gifts, matching gifts, irrevocable commitments, or gift annuities.
